**LIVE RELEASE RATE: 91.8%**

The Live Release Rate does not include 0 owner/guardian requested euthanasias which were unhealthy and untreatable (see line R) and 71 animals that died or were lost in shelter care (see line U).

Beginning Shelter and Ending Shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.
