**LIVE RELEASE RATE: 76.0%**

The Live Release Rate does not include 7 owner/guardian requested euthanasias which were unhealthy and untreatable (see line R) and 9 animals that died or were lost in shelter care (see line U).

Beginning Shelter and Ending Shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.
